Background:

In china, medical technology and relative industries have developed rapidly. But a number of emerging markets are still rooted in Southeast Asia. The prosperous development of the ASEAN countries means spend more on health care, which can lead to the development of the regional medical equipment market. Cardiovascular disease is the first killer in many Asian countries, accounting for nearly 60% of 17 million deaths every year. 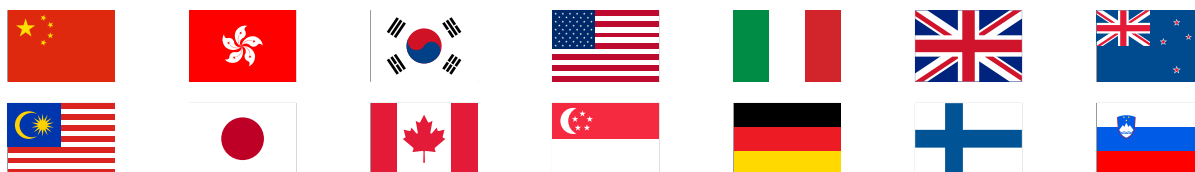
